IN FY20, MAPS' PRIMARY FOCUS WAS ON COMPLETING ITS FIRST OF TWO MULTI-SITE PHASE 3 CLINICAL TRIALS OF MDMA-ASSISTED PSYCHOTHERAPY FOR PTSD, WHICH BEGAN RECRUITMENT IN NOVEMBER 2018 AT 15 SITES (11 IN THE US, 2 IN ISRAEL AND 2 IN CANADA) AND COMPLETED GATHERING THE FINAL DATA POINT IN AUGUST 2020. DUE TO COVID, WE CAME TO AGREEMENT WITH FDA TO ENROLL 90 INSTEAD OF 100 VOLUNTEERS WITH CHRONIC, SEVERE PTSD. VOLUNTEERS WERE AT LEAST 18 YEARS OLD AND IN GOOD PHYSICAL HEALTH TO PARTICIPATE. THIS WAS TO BE THE FIRST OF TWO PHASE 3 TRIALS OF MDMA-ASSISTED PSYCHOTHERAPY FOR PTSD CONDUCTED UNDER U.S. FOOD AND DRUG ADMINISTRATION (FDA) GUIDELINES. IN FY 20, WE ALSO LAID THE GROUNDWORK TO BEGIN THE SECOND PHASE 3 TRIAL WHICH WILL ENROLL AN ADDITIONAL 100.
