IN 2021, MAPS PRIMARILY FOCUSED ON SPONSOR ACTIVITIES RELATED TO ITS TWO MULTI-SITE PHASE 3 CLINICAL TRIALS OF MDMA-ASSISTED THERAPY FOR PTSD HOSTED AT SITES IN THE U.S., CANADA, AND ISRAEL. PEER-REVIEWED RESULTS OF THE FIRST PHASE 3 TRIAL WERE PUBLISHED IN NATURE MEDICINE IN MAY 2021 AND LATER NAMED AMONG THE TOP TEN BREAKTHROUGHS OF THE YEAR BY THE JOURNAL SCIENCE. THE SECOND PHASE 3 TRIAL BEGAN ENROLLMENT AT 13 SITES IN THE U.S. AND ISRAEL IN NOVEMBER 2020; THE FINAL DATA POINT IS EXPECTED TO BE COLLECTED IN NOVEMBER 2022.
